FINANCE

A concentration in Finance opens up a variety of different career paths, which can be classified largely into investments, corporate finance and commercial banking. Investments jobs are about making money via stocks, bonds, derivatives or venture capital; thus, they require a strong understanding of how to value securities. Corporate finance careers also require an understanding of valuation, but the emphasis is on valuing projects and not on securities. For example, a student focusing on corporate finance might work for the CFO of a large company and help decide on capital expenditures for new factories, marketing budgets for ad campaigns, or how to price the company's product. Commercial banking combines the two areas because banks focus on interest rates but they lend to companies. Commercial banking also encompasses real estate lending (home mortgages), banking services, and personal loans.

Finance students learn valuation from their introductory courses as well as from the courses on investments, fixed income, derivatives, international finance and trading. These are also helpful for a career in banking. Students interested in the corporate finance area should instead focus their coursework more on corporate finance, the corporate financial policy course, and entrepreneurial finance. Students may continue their training by enrolling in the Masters of Finance or MBA programs. After that, or potentially after their undergraduate programs finish, they may pursue the CFA certification.


