STRATEGY AND ENTREPRENEURSHIP

A concentration in Strategy and Entrepreneurship prepares students to understand and make big-picture management decisions that ultimately improve organizational performance and/or lead to firm growth. The insights learned in this concentration apply to both large established firms as well as to entrepreneurial or startup ventures. There are many jobs that employ students trained in strategy and entrepreneurship, ranging from top managerial positions in organizations to positions as analysts, consultants, or investment bankers. Some students also decide to found their own entrepreneurial ventures, or to join a startup team.

Individuals involved in strategy and entrepreneurship focus on the strategic direction of organizations and often act in managerial roles. However, individuals with these skills may also serve as internal or external consultants, providing recommendations to organizations regarding strategic issues. Courses in this concentration draw heavily on case studies and experiential learning, and help students develop skills in critical thinking, problem solving, applying business theories and tools, and building sound business models.


